### **Contest Rules**

ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

# 1. Eligibility

Fireytech Customer Appreciation Drawing (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. #### 4. Contest Period

The Contest begins on June 24, 2021 and ends when Fireytech of Tulsa LLC receives 200 Google Maps Reviews (the "Contest Period"). Entries that are submitted after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

#### 5. How to Enter

There are two parts to entry.

Part one: This method of entry will be available by entering a Google Maps review (https://g.page/Fireytech/review?rc) and following the directions provided to submit a review, and submit.

Part Two: You must register by having the following information entered into our database: You name, phone number, email address and zip code. Existing customers information is already entered in our database so there is no need to re-register. No purchase necessary. Any non customers may enter by coming into our shop at the address below to be entered.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

### 6. Prize Drawing

After Fireytech of Tulsa LLC receives it's 200th Google Maps Review, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about a week from when the contest period ends. If the potential winner cannot be contacted within seven (7) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

#### 7. Winner Notification

The potential winners will be notified by email, mail or phone. The potential winner will be required to complete, electronically sign, and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period (if applicable), or prize is returned as undeliverable, potential winner forfeits prize.
